

## **Payment Terms and Conditions for E-Commerce Orders**

These Terms and Conditions of Sale ("Terms") govern all purchases made through the Ophtec webshop ("Webshop") and form a binding agreement between the purchaser ("Buyer") and Ophtec USA ("Seller"). By placing an order through the Webshop (shop.ophtec.com), the Buyer agrees to be bound by these Terms. Any conflicting terms in the Buyer's purchase order or other documents are expressly rejected unless agreed to in writing by Seller.

## 1. Products and Availability

• All products listed in the Webshop are subject to availability. Seller reserves the right to modify or discontinue products at any time without prior notice.

# 2. Pricing and Taxes

- Prices are listed in US Dollars and exclude applicable VAT, duties, and shipping fees.
- Seller reserves the right to adjust prices at any time.
- Buyer is solely responsible for all applicable taxes, duties, and governmental charges arising from this sale.

#### 3. Payment

- Buyers can choose from various payment methods available on the Webshop at the time of order placement.
- All invoices must be paid within 60 days from the invoice date, unless otherwise agreed upon.

#### 4. Shipping and Delivery

- Seller will ship all Products FOB destination. Title and risk of loss to the Products shall pass to Buyer upon delivery of the Products by Seller to the carrier. Seller retains a security interest in the Products until full payment is made.
- Buyers may choose between FedEx and UPS as the carrier.
- Shipping costs are calculated at checkout and are the responsibility of the Buyer, unless otherwise stated.
- Estimated delivery dates are provided for convenience, and no rights can be derived from such estimates.

### 5. Returns

 All sales are final and non-returnable unless the product is defective, damaged, or not as described upon arrival.

#### 6. Limitation of Liability

 To the maximum extent permitted by law, Seller shall not be liable for indirect, incidental, or consequential damages, including loss of profits or data. Total liability is limited to the amount paid for the product.



 Seller shall not be liable for damages resulting from improper use, unauthorized modifications, or failure to follow instructions.

### 7. Intellectual Property

 All intellectual property rights related to the products, and any associated documentation shall remain the sole property of Seller. Buyer should not reverse engineer, copy, or modify any product or related materials.

#### 8. Use of Products

 The products sold on the Webshop are intended for professional use only and should be used by qualified medical professionals.

### 9. Confidentiality

 Any non-public information shared between Buyer and Seller shall be kept confidential and used only for fulfilling the order.

# 10. Force Majeure

 Seller is not liable for delays or failures due to events beyond its reasonable control, including natural disasters, pandemics, or supply chain disruptions.

## 11. Governing Law

 These Terms are governed by the laws of the United States. Any disputes shall be resolved by the competent court in the state of Florida.
